

# ASSAY OFFICE report

## ACTIVITY

Following three successive record years for hallmarking, the year 2002 fell narrowly short of making it four in a row. The Golden Jubilee hallmark proved to be less popular than the Millennium Mark, being applied to less than 5% of the articles. The downturn in 9ct gold was compensated by increases in 14ct gold, 18ct gold, platinum and sterling silver. The office was used by 3,800 customers who submitted 69,000 packets containing 6.7 million articles, of which 20,000 (0.3%) were rejected. The Common Control Mark of the International Hallmarking Convention was applied to 3.8m articles. The sale of Dealers' Notices doubled to 3,954 indicating that more retail outlets are offering jewellery and silverware.

## REGISTRATIONS

During the year there were 584 enquiries, which resulted in 438 new registrations with the London Assay Office, an increase of 24%. This resulted in 793 sponsor mark punches being manufactured.

## ANTIQUe PLATE COMMITTEE

A total of 142 pieces were examined, of which 42

conformed to the Hallmarking Act, 54 bore illegal additions, 39 bore counterfeit marks, six bore transposed marks and one was a duty dodger. As ever, the Office remains indebted to the Committee and Panel members who provide their knowledgeable advice free of charge. These bare facts do not do justice to the challenges faced by the Committee and the sophistication of recent fake pieces, which has caused disquiet in the antique silver trade. The Metropolitan Police is continuing its investigation, and pieces have been seized as evidence.


## SUSPECTED OFFENCES

Apart from the above, a total of 65 suspected offences against the Hallmarking Act were reported to the Office by Local Authority Trading Standards Offices. Twenty witness statements were issued after examining articles.

## INTERNATIONAL CONVENTION

The revised, and simplified, accession procedure was used in practice for the first time by the inspection group on a visit to the Assay Office in Latvia, which has now been invited to accede to the Convention. Inspection visits have been requested by Cyprus and Israel. Ratification of accession by Poland and Lithuania is awaited. Hungary, Slovenia and Uzbekistan are actively considering accession. Representatives from Dubai attended the Standing Committee as observers for the first time. There are now more observers than members and this demonstrates that independent third party verification of precious metal articles for the purpose of free and fair trade is not just an issue which is confined to the EU. Since its inception, the Secretariat of the Convention has been provided by EFTA. As many of the original EFTA countries have transferred to the EU, EFTA is no longer the organisation it once was. The staff of the Secretariat also provided services to the Pharmaceutical Inspectorate Convention. An agreement has been reached by the two Conventions whereby the Secretariat will transfer from EFTA to the World Health Organisation. It is a fortuitous coincidence that this reflects the international interest in the Convention from countries outside the EU.

## ASSOCIATION OF EUROPEAN ASSAY OFFICES

Under the Chairmanship of Mrs M Ulaczyck of the Warsaw Assay Office, two round robins (fineness tests) were conducted. The Association is indebted to the Prague Assay Office and the Swiss Assay Office for organising the distribution of samples and collating the results. At a recent meeting, Austria reported that changing from compulsory to voluntary hallmarking had resulted in 14% non-compliance being detected by market surveillance. With the prospect of the draft directive being re-activated, the next meeting under the Chairmanship of Dr I Karis of the Cyprus

Assay Office will be useful in discerning any changes in the national positions over the past ten years. The Holland Assay Office continues to be the Treasurer and the London Assay Office provides the Secretariat.
